Minutes of the meeting of the Collegium of CZ.NIC, z. s. p. o., held on 28 June 2022 at the Learning Centre of the CZ.NIC Academy, Táboritská 23/1000, Praha 3

1. Attendance

Registration commenced at v 1:30 p.m.

2. Opening and introduction

The meeting of the Collegium of the CZ.NIC Association was opened at 2:00 p.m. with 16 of the 20 Collegium members present; therefore, the Collegium meeting was quorate.

3. <u>Election of Collegium Bodies</u>

The Collegium Bodies were elected unanimously as follows: Petr Hostaš, Chairman of the Meeting; Zbyněk Pospíchal, Scrutineer and Minutes Verifier; Zuzana Průchová, Recording Secretary.

4. Report on the activities of the Board of Directors

K. Taft, Chairman of the Board of Directors, briefed the Collegium members on the activities of the Association's Board of Directors in the period from 1 January 2022 to 31 May 2022.

The Board of Directors of the Association dealt with the management of the Association and the control of its activities and the status of individual projects, including the Association's participation in grant projects, blocking of so-called disinformation websites in connection with the invasion of the Russian Federation troops into Ukraine (also in this context, the Association began to publish a list of domains that are excluded from the DNS for various reasons), it also dealt, among other things, with the amendment of the Association's Statutes or the hosting of the CENTR organization meeting.

17 out of 20 Collegium members were present

The Collegium acknowledged the report on the activities of the Board of Directors.

5. Supervisory Board's Report

Jan Redl, Chairman of the Supervisory Board, briefed the members of the Collegium on the activities of the Supervisory Board of the Association in the period from December 2021 to May 2022. The activities of the Association were regularly monitored, and, among other things, the Supervisory Board carried out an audit of the management for the year 2021, discussed the financial statements for the year 2021, carried out an audit of the management for the 1st quarter of 2022 and an audit of newly concluded contracts, got acquainted with the status of internal projects and their plan for the year 2022. The Supervisory Board also acknowledged the Association's actions in connection with the conflict in Ukraine and it positively evaluates the provided financial and technical assistance; also dealt with the circumstances and motivation of blocking the domains of disinformation websites, perceives the measure taken as an exceptional step in an exceptional time, does not see it as exceeding the Board of Directors' powers, and positively evaluates efforts to communicate with the state aimed at clarifying solutions to similar situations in the future.

The Collegium acknowledged the report on the activities of the Supervisory Board.

6. Information about the Association's projects

O. Filip introduced the Association's current projects and the evaluation results of these projects to the Collegium.
