

# Minutes of the General Meeting of CZ.NIC, z.s.p.o. conducted by electronic voting at https://intranet.nic.cz between 16 and 30 June 2017 (inclusive)

In a message dated 16 June 2017 submitted to the members' electronic conference at <a href="mailto:nic-c@lists.nic.cz">nic-c@lists.nic.cz</a>, Executive Director Ondřej Filip invited members of the Association to vote on the documents posted on the Intranet of CZ.NIC, z.s.p.o. at <a href="https://intranet.nic.cz">https://intranet.nic.cz</a>.

At the opening of voting, 99 members of the Association held voting rights in accordance with Article 12.1 of the Statutes: 24 members for the ISP Chamber, 59 members for the Chamber of Domain Holders and 16 members on behalf of the Chamber of Registrars (see Annex 1 to the Minutes for a list of members with voting rights; for a list of observer members without voting rights, see Annex 2 to the Minutes).

The members voted on the following items on the agenda:

#### 1. Financial Statements for 2016

The board of directors submitted the 2016 Financial Statements to the General Meeting and recommended that they be approved. The voting was based on the following documents:

- Directors' Report for the period 1–5/2017
- Report of the Supervisory Board for the Period between 12/2016 and 5/2017
- Fulfilment of the Budget for 2016
- Auditor's Report for 2016
